This exciting programme allows you to delve deeper into the world of entrepreneurship. It will give you a comprehensive academic grasp of entrepreneurship and will hone your entrepreneurial skillset. This powerful combination of knowledge and skills will guarantee you a challenging career, be it as an entrepreneur or as an employee in an entrepreneurial organisation. The programme also offers ample space for customising your programme, in the form of electives, internships or entrepreneurial endeavours. All of this takes place in the entrepreneurial environment that Amsterdam has to offer.

This one-year programme takes a thorough look at two modes of entrepreneurship: new commercial ventures and entrepreneurial activities within organisations. You will look at the multidisciplinary aspects of entrepreneurship and the many practical issues that influence it. Specialisation courses allow you to gain in-depth knowledge of entrepreneurship in specific contexts. Throughout the programme there will be plenty of opportunities to apply your newly gathered knowledge and gained entrepreneurial skills to practice. The programme culminates in a thesis that can be combined with an internship.

This programme is ideal for enthusiastic and ambitious students from a diversity of backgrounds. Within this programme you:

- Gather crucial knowledge on entrepreneurship and gain important entrepreneurial skills.
- Create your own programme in the form of electives, internships, and your own entrepreneurial endeavours.
- Study in a city that hosts a vibrant entrepreneurial ecosystem.
